Applications are invited for admission in NUST Mil Constituent Colleges (**MCE, MCS and College of E&ME**, as PCs and for UETs (**UET Lhr, UET Taxila, UET Psc, NED UET Kci, Dawood UET Kci, Mehran UET Jamshoro and UET Nawabshah**) against Army res seats for the **session 2025**. GHQ prescribed application forms will be aval (free of cost) at all Corps HQ, Sta HQ/Army School of Instrs/all DASBs and Army Help Centre, Hilal Road, Rwp by **last week of Apr 2025**. Applicants attaining min of **60%** aggregate mks each in **Matric and FSc separately** or equivalent are eligible to apply. **Candidates with O/A level or equivalent qualification can apply on the basis of O Level (SSC) equivalence certificate obtained from Inter Board Committee of Chairman (IBCC).**

Furthermore it is **also mandatory for candidates to apply on open merit of concerned UET of province whose domicile they possess**. Candidates can only apply in main campus of all civil UETs.

4. Students of Mil Colleges can only apply for admission after obtaining **NOC** from their respective institution. **Application form will not be accepted without NOC and sp docus**.

5. Last date for submission of application forms to AG's Branch (W&R Dte/WR-2A) GHQ Rawalpindi is **11 Jul 2025 (Friday)**. OAS user can download admission form **session 2025** from Army Portal (W&R Dte) and photocopy of the form will also be acceptable.
